- Boarding rates are \$10.00 per day, including days on the road. This includes feeding, training and conditioning. All dogs enjoy sufficient time indoors with the family as house pets and receive adequate exercise for their breed.
- A \$300.00 deposit must be paid before I take possession of the dog. This deposit will be put toward your final bill.
- An airport charge of \$100.00 will apply to pick up from CAK, CLE, PIT or CMH.
- An initial grooming fee of \$\_\_\_\_\_ will be charged for incoming client dogs, and will be charged per circuit.
- An initial veterinary fee will be charged to your first bill, as all client dogs must be examined by our veterinarian upon arrival at our facility.
- All veterinary expenses will be billed monthly at cost, including fee/tick treatment, heartworm preventative and routine vaccinations.
- All entries are made by the handler and a \$5.00 entry service fee applies per entry.
- Owners will be billed on the last day of each month (+ or – a couple of days depending on how show weekends fall). If payment is not received by the 15<sup>th</sup> day of the following month, a 10% late fee will be added to the unpaid balance each month.
- Expenses are divided among all clients. Expenses include hotel, gas, parking, airfare, rental car, etc. Gas expense is \$0.35 per mile, round trip.
- All accounts have a credit limit of \$500.00. Once an account is \$500.00 past due, the clients dog will no longer be shown until balance is paid in full.
- Non-sufficient check fee is \$25.00 plus my bank fee.
- I accept cash, check, Visa, MasterCard, Discover and American Express.
- Any account turned over for collection will be charged court costs, legal fees and collection fees.

- Prize money is property of the handler. Non-monetary prizes are the property of the owner and will be handed to or mailed to the owner.
- All postage will be billed to owner.
- If a dog is taken to a show but not shown due to illness of the dog, or personal reasons of the owner beyond the handlers' control, expenses are still billed to owner.
- Handler is permitted to use her discretion when she has two client dogs competing for winners, group or best in show.
- In the case the handler cannot make the ring, another qualified handler will take the dog into the ring.
- Owner agrees that handler shall not be held responsible for illness, death or loss of dog unless by handlers own negligence.
- Signed schedule of fees, contract and power of attorney as well as copies of the dogs' certificate of vaccination and AKC registration must be on file with me before I can take possession of your dog.
- All dogs must be up to date on rabies, distemper, hepatitis, parvo and leptovaccines as well as heartworm and flea/tick prevention.
- Ring Side Pick Up refers to dogs that are brought to the show by their owners, groomed and prepared to go into the ring before in the handlers' possession. These owners are still responsible for their portion of divided expenses.
- Win photos will be taken at the request of the owners or at the handlers discretion.
- Handler reserves the right to use photos of client dogs in advertising.
